LESSON: Terms of History

GRADE(S): 4th grade and up

LEARNING OBJECTIVES:

American Heritage

1. Demonstrate knowledge of and ability to think about the relationship among events by:
 - Identifying sequence of events in history
 - Grouping events by broad historical era on a time line;
 - Recognizing that change occurs in history; or
 - Identifying cause and effect relationships
2. Identify and use sources of information about a given topic in the history of Ohio and the United States.
3. Relate major events and individuals in state history to time periods in the history of the nation and the world.

1. Students will be able to identify key terms in the study of history.
2. Students will be able to locate and identify the primary source documents from collections of historical documents.

ACTIVITY: Historical Documents

Opening:

1. Primary source documents give a first hand view of the events of the past. Looking at these documents give an understanding of key phrases or terms of history.

Main Activity:

1. Students or pairs shall be given a key term of historical importance for which they will search for a document relating to this term.
2. Students will complete the worksheet for the term describing the primary source document and locate its date (optional).
3. Students will place the documents on a timeline of U.S. history and Ohio history.

Questions to Ask:

1. What are the important issues that were talked about in both documents?
2. Which document came first?
3. Why were these documents related to the term you were given?

Closing:

1. Primary documents provide great details for history for the person studying the past. Primary source materials talk to us about events and people of the past as if they were there.
